## ANNUAL AWARD SCHOLARSHIP

The South Okanagan Real Estate Board has established an annual award scholarship of \$1,000 which will be awarded based on a combination of the applicant's academic, service, fine arts and athletic performance. The Real Estate Board believes that the secondary school graduate of today experiences and involves themselves in a wide range of activities beyond the academic scope and the Scholarship will recognize this well-rounded individual. Preference will be given to immediate family members and staff of the South Okanagan Real Estate Board and permanent residents of the South Okanagan.

The South Okanagan Real Estate Board will contribute \$1,000.00 annually to the Fund and will hold and administer the Fund, together with any additional contributions, on the following terms and conditions.

The successful applicant is required to submit proof of registration in a recognized university, college or institute of their choice in order to receive the scholarship awarded to them. Upon receipt of proof the monies will be forwarded to the successful applicant.

### CANDIDATE CRITERIA

An Annual Award will be disbursed to a recipient who meets the following criteria:

- a) preference will be given to immediate family members of the South Okanagan Real Estate Board membership and staff;
- b) the recipient must be a permanent resident of the South Okanagan;
- c) the recipient will have completed one or more years of full-time study in the Business Administration degree or diploma program and will be returning the following September for a subsequent year of full-time study, leading to a career in business related to Real Estate or Land Management;
- d) if no one applies that has the above qualifications, the selection of the award recipient will be based on a combination of academic achievement, financial need and that the recipient is in good standings academically at the time of application.

### APPLICATION REQUIREMENT AND DEADLINE

The application consists of the following:

- a) General Information & Declaration Form
- b) Student Activities Form
- c) Personal Goal Statement

Completed Scholarship Application and all documents listed above must be returned to the SOREB office on or before August 15.

## DISTRIBUTION

Selection will be made by the South Okanagan Real Estate Board Member Services Committee in August with the successful applicant being notified in September.

The principal amount of the donation made to the Fund for the purposes of the award, or any portion thereof, may be disbursed annually or from time to time as the Board of Directors of the South Okanagan Real Estate Board, in its absolute discretion shall determine for purposes which are in conformity with the award criteria. The Board may, in its absolute discretion, determine not to distribute the entire award in any fiscal year but may instead hold such amounts in the Fund to be distributed in a subsequent year.

If, in the opinion of the Board, it should become impossible, inadvisable or impractical to apply the Fund for the specific purposes stated herein, then the Board of Directors will use its reasonable best efforts to discuss an amendment to the specific purposes which is as close as possible to the original purposes of the Fund.

In the event of the winding up or liquidation of the South Okanagan Real Estate Board, the Fund will be distributed in accordance with the constitution of the South Okanagan Real Estate Board as amended from time to time.

## ADDITIONAL CONTRIBUTIONS

The South Okanagan Real Estate Board may accept additional contributions to the Fund from any person, corporation, society, foundation, organization or other entity and upon request shall issue appropriate income tax donation receipts in respect thereof.

## EXPENSES

The South Okanagan Real Estate Board may deduct its reasonable expenses incurred for administering and managing the Fund from the Fund.

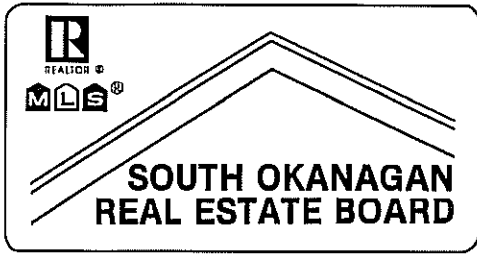
## AMENDMENT

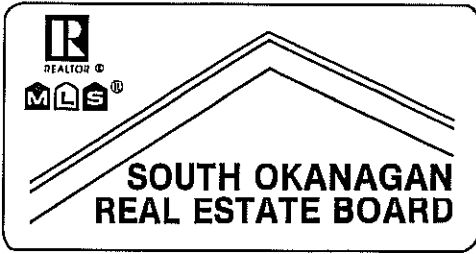
